## Honeoye Lake Watershed Task Force April 2024 Update

#### 1. Honeoye Lake Update

- a. Honeoye Lake ice in date was January 16th and ice out date was February 13<sup>th</sup> (2024).
  Just four (4) weeks of ice cover so far this winter. The lake currently remains ice free.
- b. Lake level currently ~1 foot high. Mean High Water level is 804.6 (`1.5 feet high) Rainfall in 1Q24 and March 2024 was normal.



#### 2. DEC Large Scale Pilot Study to Control Phosphorous Impacts in Honeoye Lake Update

a. DEC has launched a study to try and determine why we did not see the expected water quality improvements in the summer of 2023 from their Nov 2022 Alum Treatment.

#### 3. Our New York State WQIP Grant Funded Projects

- a. An aeration system is still a viable long-term approach worth considering to address Honeoye Lake's HABs issue.
- b. This potential project will be revisited once we know when the DEC Alum Pilot monitoring and analysis will be completed in 3+ years.
- 4. Honeoye Lake Boat Cleaning System Grant was awarded on December 13<sup>th</sup>, 2023. Funded by the NYS Environmental Protection Fund (EPF).
  - a. Ontario County: Honeoye Lake boat wash station and aquatic invasive species (AIS) prevention project, \$39,985: A project that engages the public in the prevention of aquatic invasive species through the installation of a selfservice boat wash facility at the Honeoye Lake State Marine Boat Launch.
  - b. Ontario County has received the NYS grant contract for the boat wash station. Once NYS has accepted the county's contract replies NYS will make the grant funds available.
  - c. An Ontario County Water Resource Council \$3,000 Grant was awarded in January to provide funds for Boat Cleaning System Educational Outreach material and other miscellaneous expenses associated with deploying a boat cleaning system.

It could be used for an energy audit at our town hall or for a heating system or whatever improvements could be made to make us more efficient. There are several options this money could be used for. This would also move us along towards a 2-star rating, which at that time we would be eligible for \$50,000.00 additional money.
